Lexington, Kentucky November 9, 2017

The Council of the Lexington-Fayette Urban County Government, Kentucky convened in regular session on November 9, 2017 at 6:03 p.m. Present were Mayor Gray in the chair presiding, and the following members of the council: Kay, Lamb, Moloney, Mossotti, Plomin, Scutchfield, Smith, Stinnett, Bledsoe, F. Brown, J. Brown, Evans, Farmer, Gibbs, and Henson.

The reading of the Minutes of the previous meeting was waived.

Ordinances No. 154-2017 through 156-2017, inclusive, and Resolutions No. 632-2017 through 658-2017, inclusive, were reported as having been signed and published and ordered to record.

The Invocation was given by Chaplain Donovan Stewart, Div. of Police.

Mayor Gray asked Mr. J. Brown to introduce Mr. H.B. Deatherage of the Kentucky Veterans Hall of Fame. Mr. J. Brown introduced Mr. Deatherage and described an upcoming event that will be held in Lexington.

Mr. Gary Griesser sang the National Anthem, and displayed a slide presentation to better describe the upcoming event and the mission of the organization. Mr. Deatherage and Mr. Griesser commented at its conclusion about the Hall of Fame and its membership. The gentlemen presented Mayor Gray with a gift to demonstrate the City's relationship with the Ky. Veterans Hall of Fame.

Mayor Gray recognized several members of the Montclair Neighborhood Association and thanked them for attending the meeting.

A Resolution authorizing and directing the Mayor, on behalf of the Urban County Government, to execute an Agreement with the Ky. Transportation Cabinet (KYTC), for the exchange of a total of approximately 34.658 road lane miles located in Lexington-Fayette County, with KYTC to receive approximately 19.6 road lane miles and the Urban County Government to receive approximately 15.058 road lane miles; and authorizing the Mayor, or his designee, to sign any necessary documents related to the exchange was on the docket for first reading.

Upon motion by Mr. Gibbs, seconded by Ms. Mossotti, and approved by unanimous vote, the resolution was taken out of order to be considered before other items and to permit public comment.

Mr. Gibbs moved to postpone the first reading of the resolution until the Council Meeting on November 16, 2017. Mr. Farmer seconded the motion.

Mr. Moloney expressed concerns with postponing the resolution.

The motion passed by majority vote (Mr. Moloney voted No).

Commissioner Dowell Hoskins-Squier, Dept. of Environmental Quality and Public Works, spoke about the resolution, and the benefits that accrue to both the Commonwealth of Kentucky and the Lexington-Fayette Urban County Government as a result.

The Council discussed a matter of procedure and Mr. Randolph continued his comments.

Ms. Henson asked about changing the roads selected for the road swap, and whether other residential roads are State roads. Ms. Hoskins-Squier responded.

Mr. Farmer asked about discussions with the University of Kentucky about its feedback on the proposed road swap. Ms. Hoskins-Squier responded.

Mayor Gray spoke about a meeting with State road engineers. Ms. Hoskins-Squier also spoke about the meeting.

Ms. Hoskins-Squier explained the theoretical process that would occur if Cooper Dr. were to be widened.

Mr. Moloney talked about the premise of giving up a street.

Vice Mayor Kay expressed understanding for the concerns about the swap; however, he also talked about his experience as a member of the Metropolitan Planning Board and how the Board operates. He talked about his perception of the unlikelihood of Cooper Dr. changing in any perceptible way as a result of the swap.

Mr. J. Brown asked about the classification of the street and how that might change in the future. Ms. Hoskins-Squier responded.

Mr. J. Brown expressed his appreciation for Mr. Gibbs: his experience, his integrity, and his desire to do the best he can for his constituents. Ms. Mossotti concurred with Mr. Brown's comments about Mr. Gibbs.

Ms. Mossotti asked about the timeline for the proposed road swap. Ms. Hoskins-Squier responded. Mr. Farmer responded.

Mr. Stinnett asked about communication that may have taken place with stakeholders at the State level. Ms. Hoskins-Squier responded.

Mr. F. Brown talked about the various issues involved in the road swap.

Mayor Gray thanked everyone for participating in the meeting.
